Torture in Iraq: *No Monopoly on Capacity For Evil*

The Fellowship of Reconciliation, the oldest peace organization in the United States, issued the statement below on May 13, 2004 on the violence in Iraq and the mistreatment of prisoners. In July last year, President Bush was asked whether the invasion and occupation of Iraq might prompt anti-American Al Qaida forces, who had never operated in Iraq before, to travel there to attack Americans. The president's response, in his characteristic Clint Eastwood western style, was, "Bring 'Em On." They came. Thanks to the folly of the U.S. administration's policies and attitudes, Al Qaida-related groups have created a new theater of terror where none existed before. The shocking decapitation of an American contractor this week by Al Qaida operatives is evidence of that.

President Bush's cavalier attitude, coupled with the ongoing demonization of the Arab and Muslim world since Sept 11, 2001, also sent another message, this one to the U.S. military. The intelligence interrogators and prison guards in Abu Ghraib prison understood it well. If Al Qaida were "the evil ones" and Iraq was an Al Qaida operating base, then their prisoners were as evil as though they personally flew planes into the World Trade Center.

In addition to the dehumanization of the enemy, Americans have given themselves a charter of immunity. Since 9/11 and the invasion of Afghanistan, the Bush administration has claimed exemption for the United States from the constraints of international law. It is as though the U.S. is so fundamentally good, its purpose so noble, that it cannot and should not be bound by the Geneva Conventions, the International Criminal Court, or the need to listen to the international community.

The systemic violence at Abu Ghraib is

Greenpeace Acquitted: Judge Finds Greenpeace Not Guilty in Landmark Free Speech Case

The Bush administration's attempt to prosecute Greenpeace failed today when Judge Adalberto Jordan dismissed the charges in the midst of the trial. Shortly after the Justice Department rested its case, the judge granted Greenpeace's motion for acquittal, ruling that there was insufficient evidence to send the case to the jury. Greenpeace was the first organization to be prosecuted for the free speech activities of its supporters.

"America's tradition of free speech won a victory today but our liberties are still not safe," said Greenpeace Executive Director John Passacantando. "The Bush administration and its allies seem bent on stifling our tradition of civil protest, a tradition that has made this country stronger throughout its history. Greenpeace is grateful to everyone who stood with us — from former vice president Al Gore and NAACP Chair Julian Bond to the citizens of Miami and people around the world. We will never give up the struggle to protect our forests, our air, and our water and to build a green and peaceful future."

The case stems from a protest that took place several miles off the coast of Florida in April 2002. Two Greenpeace activists peacefully boarded a ship that was carrying illegal mahogany wood from the Brazilian Amazon into the Port of Miami. The activists, who clearly identified themselves as Greenpeace, intended to hang a banner that read "President Bush: Stop Illegal Logging." The individuals involved in this nonviolent protest were arrested, and misdemeanor charges against them were settled later that year.

However, instead of intercepting the illegal mahogany and prosecuting the smugglers, the Justice Department filed criminal charges against Greenpeace on July 18, 2003. Greenpeace was charged under an obscure 1872 law against "sailormongering," aimed not at protestors but at unscrupulous 19th-century innkeepers who would attempt to lure sailors to their establishments.

Numerous leaders, legal scholars and groups publicly criticized the prosecution, including Al Gore, Senator Patrick Leahy, the NAACP, the ACLU of Florida, People for the American Way, and the Sierra Club.

Eric Sirotkin talks about his recent trip to North Korea where five lawyers were invited to travel to the north of the DMZ and Pyongyang, meet with lawyers, governmental officials and military leaders in an effort to discuss peace, nuclear weapons and life in the Democratic Peoples Republic of Korea (DPRK). Their findings reveal the false and deceptive information promulgated by the U.S. government about the DPRK to mask an effort to hide a broader plan for war.

Sirotkin is returning to the DPRK in October.



Regime Change Begins at Home

Progressive activists are already lining up to help defeat the Bush administration's reelection campaign this November. With the brutal occupation of Iraq in the headlines daily, and with further evidence of atrocities mounting each week, Bush's approval ratings are beginning to plummet. And progressives are seizing the opportunity to shine a light on this rogue regime and their reckless policies.

Before long, the campaigning will reach a fever pitch, with the incumbent talking about restoring "security" to the homeland and winning the "war on terrorism." Meanwhile the war will drag on and the scandals will continue to unfold, causing untold thousands to recognize the need to do whatever is necessary to ensure this administration is kicked out of office in November.

While some may lament the lack of a strong progressive voice in the opposition of John Kerry, and many others remain focused on supporting Dennis Kucinich in an attempt to sway the Democratic party towards progressive values while staying engaged in the electoral process. Others feel completely left out of the process.

There is a way to take the feelings of disempowerment and unite as a community that cares about our future. This summer, there is a very concrete opportunity to organize a campaign locally. And it is a campaign we can win.

The Bush administration's war on the environment is as cruel and calculated as their war in Iraq. This regime has done more to undermine environmental laws than any administration in generations. Right here in the Klamath-Siskiyou bioregion, they have already done away with protections for sensitive and threatened species, roadless areas, old growth reserves and salmon.

This summer alone, thousands of acres of

our public lands could be opened up to their timber industry sponsors for logging, without these protections. They could go as far as removing the public process that ensures citizen involvement in decision-making, turning back the clock on struggles won in the past to ensure protection of our public lands.

In all the polling, 75% of Oregonians want to see the remaining native and old growth forests on our public lands protected from logging and other resource extraction.

Oregon is already being touted as a swing state in the upcoming election. With the help of all progressive activists in Oregon, the forest protection movement could push back the assault of the Bush administration right in our own backyards.

This summer will provide folks many opportunities to plug into campaigns and actions. Greenpeace USA has opened their Global Forest Rescue Station in the Siskiyou mountains. This is a place where the public can come and see first hand the threats to our region and learn skills to defend these forests. The Klamath-Siskiyou Wildlands Center (KS Wild) and the Friends of the Rogue-Kalmiopsis (FoRK) will be leading hikes into many of these threatened places. The Northwest Regional Earth First! Rendezvous is scheduled for June 10-14 in the Biscuit fire.

This is just a sampling of possible opportunities to get involved. Stay tuned to this newsletter for further updates along the way. And please visit these websites for more information about the forest protection movement and how to get involved.

War on Faith Language as a Weapon

I recently returned from a 25-day West Coast road show where I met hundreds of people and talked with them about the plight of forest ecosystems in the Pacific Northwest. I found that while many people are not surprised to hear that the Bush administration is weakening and eliminating environmental laws, many expressed confusion about the language being utilized by the administration.

When Bush came into office I dusted off a copy of George Orwell's 1984 because I felt it would be a good piece of literature to reread. Unfortunately, I was right. And fortunately, it helps me to reconcile the gaps between what this administration says, and what I see with my own eyes. To be content, the American public needs to be abreast of government activities. It is, however, often easier to just believe what we are told or perhaps to not see what is obvious.

I struggle with the terms "friendly fire." "Operation Enduring Freedom," "collateral damage," and "coalition of the willing." I also struggle with the terms "healthy forests" and "Biscuit Fire Recovery Plan." All of these terms sound reasonable, or at least use a smokescreen of clever language they harmless enough in the face of problems that demand answers.

I am reminded of the term "manifest destiny" which was used in the 19th century to justify the sweeping colonization of North America by insisting that America had a "destiny" to dominate the continent. Earlier in that century, the Monroe Doctrine declared in 1823 that European colonial powers had no right to be in Latin America, suggesting that self-rule was a high social value. Yet "manifest destiny," combined with the Monroe Doctrine, gave America the mental acceptance to dominate the Western hemisphere in

the late 1800s and into the 20th century.

I believe that people truly want to live in a peaceful place where they can love their families and friends without harm. Yet this administration knows all too well that if they are able to paint an altruistic picture while truly implementing a deep-rooted policy of domination and expansion. We should talk about the language of War and the language of the war against the Earth this month, as Bush prepares to make Iraq "sovereign" with tanks and make the forest "healthy" with log

Message from Craig and Cindy Corrie Rise in Birth Deformities Blamed on

Thank you to all who recently paused to remember our daughter Rachel Corrie and to call for an end to the occupation—an occupation which took her life, as surely as it has taken the lives of thousands of Palestinians and Israelis.

Rachel looked for purpose and found that in Gaza when she went there in January 2003. Brutally killed one year ago, she was an unarmed, nonviolent, peace activist trying to prevent the demolition of the home of a Palestinian pharmacist, his wife, and three children. She believed that the nonviolent activism that she was doing and supporting would make not only Palestinians but also Israelis and Americans more secure— by supporting Palestinians who practice nonviolent rather than armed resistance and by speeding an end to this conflict that has so damaged both U.S. and Israeli images in the world. Rachel stood there that day because the United States government and Israel rejected a proposal in the UN to send international human rights monitors to the region. She and other activists went in their place. and they continue to go. Rachel stood there that day protesting illegal home demolitions that the U.S. opposes on the record, yet fails to stop—devastating demolitions that we, in fact, contribute to with billions of U.S. tax dollars annually that fund the Israeli military with its bulldozers, apache helicopters, F-16s, and more. In fact, the U.S. Government, with our tax dollars, surely purchased the Caterpillar D9R bulldozer that killed Rachel.

Rachel's case is closed in Israel and only the "Conclusions" to the military police report have been given to the U.S. We have been able to view the report at the Israeli Consulate in San Francisco. It contains inconsistencies and fails to satisfactorily reconcile the differences between the Israeli soldiers who say they did not see Rachel and the seven international eyewitnesses who say she was clearly visible. We believe that only an independent U.S. investigation can produce a result that we can trust. We continue to call for support and passage of House Concurrent Resolution 111 (HCR111) that calls for such an investigation and now has fifty-six cosponsors, including Greg Walden.

Rachel wrote, "When I am with Palestinian friends I tend to be somewhat less horrified than when I am trying to act in a role of human rights observer, documenter, or direct-action resister. They are a good example of how to be in it for the long haul. I know that the situation gets to them— and may ultimately get them— on all kinds of levels, but I am nevertheless amazed at their strength in being able to defend such a large degree of their humanity- laughter, generosity, family-time— against the incredible horror occurring in their lives and against the constant presence of death...I wish you could meet these people. Maybe, hopefully, someday you will."

In September we traveled to Gaza and visited the families in whose homes Rachel had stayed. All were threatened with demolition because of their location near the Egyptian border and the giant steel wall being built



there. We shared meals with these families and played with their children. In recent months all of their homes have been demolished.

In the West Bank, we witnessed the strategy of separation taking physical form in the web of fences, walls, identification cards, and checkpoints that separate not only Palestinians from Israelis, but Palestinians from Palestinians, farmers from their fields. children from their classrooms, workers from their jobs, the sick from their healthcare, the elderly from their grandchildren, municipalities from their water supplies, and ultimately a people from their land. In Jerusalem we met members of an Israeli-Palestinian organization "Bereaved Parents" who have lost relatives to the conflict and now work together to end the occupation, and then for peace and reconciliation. In Israel, we met with peace activists who asked us to return home and work to end U.S. funding of the occupa-

After a year spent learning more, and after experiencing so personally the loss that thousands of Palestinians and Israelis share with us, we echo once again Rachel's plea for it all to end, "This has to stop. I think it is a good idea for us all to drop everything and devote our lives to making this stop. I don't think it's an extremist thing to do anymore. I still really want to dance around to Pat Benetar and have boyfriends and make comics for my coworkers. But I also want this to stop."

Rise in Birth Deformities Blamed on Allies' Deadly Weaponry

The number of babies born deformed and children suffering leukemia have soared because of the "deadly legacy" of depleted uranium shells used by British and American forces in Iraq, human rights campaigners claim

Releasing details of health problems and human rights violations suffered by Iraqi children in the past year, they claim the country's youngsters faced a worse existence today than they did under Saddam Hussein's dictatorship. Depleted uranium was widely used by Allied forces to penetrate Iraqi tank armor in the Gulf Wars of 1991 and again last year.

Opponents claim the dust it releases upon impact is rapidly absorbed into the body, causing an upsurge of serious health problems inherited by Iraqi children during the past 13 years from their parents.

Caroline Lucas, a Green Party Euro-MP who recently visited Basra, said doctors there had told her that the number of children born with severe deformities, such as shortened limbs or eye defects, had increased sevenfold since 1991. In addition they were treating several new cases of leukemia every week - before 1991 the condition was very rare.

"Women in Basra are afraid to become pregnant because there are so many deformed babies," she said. "We are leaving a deadly legacy for generations to come." Lucas made the claims at the launch in London of a new charity, Child Victims of War (CVW), to help Iraqi youngsters "innocently suffering malnutrition, disease, disability and psychological trauma".

The amount of depleted uranium used by coalition forces in the two Gulf Wars is not known, but some estimates suggest it was 300 tons in 1991 and five times as much last year.

CVW says the number of Iraqi babies born with serious deformities has risen from 3.04

per thousand in 1991 to 22.19 per thousand in 2001. Babies born with Downs Syndrome have increased nearly fivefold and there had been a rash of cases of previously little-known eye problems.

The Ministry of Defense insists depleted uranium poses a "minimal" risk to civilians. But, researchers recently discovered radiation levels from destroyed Iraqi tanks to be as much as 2,500 times higher than normal in the surrounding area.

Joanne Baker, the director of CVW, said children had also been maimed by cluster bombs, blamed by Human Rights Watch for "hundreds of preventable civilian deaths".

Baker said malnutrition had worsened since the Anglo-US invasion and unpolluted water was in short supply while standards of hospital care had fallen because of shortages of medical supplies. Those children who went to school - and a Christian Aid survey showed two-thirds of poor youngsters did not - were "so malnourished they can't concentrate".

Ms Baker claimed: "Every child in Iraq had a degree of psychological trauma. "I have been to Iraq under Saddam and sanctions - most people know how bad things were - but what has happened this year has plunged Iraq into a plight which is actually far, far worse," she said. "I am not an apologist for Saddam but I have spoken to people saying they suffered terribly and they are in tears saying 'I wish he was back'. "If it is worse than sanctions and Saddam then we are really talking about a humanitarian catastrophe."

CVW plans to open an office in Iraq to monitor abuses, counsel those who have been detained, train human rights groups and provide medical help to young victims of war.

Counter-Military Recruitment Program Update

The need to work against militarism has never been clearer. As anti-war activists we must address the root causes and tools of war. It is vitally important to support low-income and youth of color in our communities being targeted by military recruiters in public schools. There is an economic draft RIGHT NOW that we must address, organize against, and defeat. Many feel powerless to resist this endless war. Direct action in response to violence and corporate aggression is of the utmost importance, but working with young people to illustrate military recruiters hype and provide alternatives is absolutely essential for creating a nonviolent and sustainable culture.

Peace House (PH) staff has been working to revamp the counter-military campaign. We've been hosting monthly organizing meetings. The next meeting is Monday, June 21st at 7:00 pm at PH, 543 S. Mountain. Call 482-9625 for more info.

We plan to attend the National Network Opposing the Militarization of Youth conference this June 25- 27 in Philadelphia. We're earnestly soliciting money and flight miles from Peace House supporters to help with plane tickets and travel. Attending the NNOMY conference would increase our skills, resources and capacity to organize in southern Oregon.

There are many concrete things we can do here at home to bring peace.

Alternatives to Military Enlistment: Most recruits join the military for college funding. PH aims to publish an exhaustive guide of alternative college financing, internships and job training available. We need volunteers to research scholarship, worktrade and other alternatives for youth leaving high school.

Curriculum Development: We hope to publish a counter-recruiting tool-kit that will assist individuals or groups working to advocate for low-income and youth of color targeted by military recruiters. We need volunteers wanting to participate in a working group.

Veteran Advocacy and Outreach: PH is working to establish connections with veterans in our area interested in helping out with classroom presentations in high schools. Are you a veteran? Do you know any veterans? Have you worked as an advocate of military service members? Are you interested in researching available resources for veterans and specifically troops returning from Iraq?

School Outreach: We need contacts. Are you a high school student, parent or teacher? Do you know any students, teachers or administrators that might be interested or receptive to classroom presentations, options for college financing or working on challenging military presence in high schools? We need volunteers to make contacts and create working groups to organize events.

Opt-Out Fall Registration: We hope to present all students and parents with detailed information about opting-out. We need volunteers to contact high school principals to create a strategy to ensure all parents and students receive bi-lingual opt-out packets at fall registration.

Peace House was thrilled to welcome Fernando Suarez del Solar to our community last month. Fernando lost his son in the early days of the Iraq war when he stepped on an unexploded US cluster bomb. He has since traveled the country to talk with communities about the horrors facing soldiers in Iraq and in particular, to speak with young people considering joining the military. His work is an inspiration to all interested in resisting this illegal and immoral war. Check out www.mfso.org for more about Fernando and other military family's work to bring the troops home now and end this war.

PH has the opportunity to host a tour of Israeli military Refusniks (soldiers who refuse to serve in the Occupied Territories). We are interested in researching services and opportunities to support veterans returning from Iraq. We are also interested in helping create a conscientious objector counseling group. But we need your help!

Concerned about the Draft?

The current administration is gearing up the draft to be ready by June 2005. Military planners acknowledge the need for more soldiers. Unfortunately, voluntary enlistment has not grown as hoped, and half the soldiers in Iraq said they are "not likely" or "very unlikely" to reenlist.

The Bush administration has allotted \$28 million to the 2004 Selective Service System (SSS) budget for a draft. It is scheduled to report to Bush in the spring of 2005 that the system is ready for activation within 75 days of March 31, 2005, i.e., by June 15, 2005.

The SSS is the federal agency responsible for registering all U.S. men at age 18, and then recruiting them. The agency has recently filled all 10,350 draft board positions and 11,070 appeals board slots.


Congress is also talking about bringing back the draft. To ease the burden on the Reserves and the National Guard, Congress brought twin bills, the Universal National Service Act of 2003 (S. 89 and H.R. 163) forward, carried by Senator Fritz Hollings (D-S.C.) and Representative Charles Rangel (D-NY). The Act remains active in the Committee on Armed Services.

To expect a draft in the spring of 2005 – after the Presidential election is over – is only realistic; it seems like a certainty if Bush is reelected and remains unknown if Kerry should win.

A group of concerned Ashlanders are organizing a meeting at the Peace House on Wednesday, June 9th from 7-8:30pm to become informed, discuss the potential consequences of a draft, alternatives (such as Conscientious Objector status) and share ideas and questions. Hopefully we can develop awareness and action points to empower ourselves and make our voices heard. Questions, call Wendy Harris 552-0113.

MONSANTO BACKS DOWN ON GE WHEAT!

The Organic Consumers Association launched its anti-GE wheat campaign two years ago to educate consumers and farmers about the hazards of GE wheat. This campaign has evolved into OCA's "Millions Against Monsanto." After years of intense pressure from the OCA and the global grassroots, Monsanto has decided to shelve plans to introduce its controversial genetically engineered Roundup Ready wheat.

"This is the beginning of the end of genetically engineered crops," said Ronnie Cummins, National Director of the OCA. "This is a bitter defeat for Monsanto and a well-deserved victory for family farmers and consumers." Farmers across North America have been resisting the introduction of the biotech wheat crop, based on concerns over its negative impacts on the economy and the environment. Farmer resistance has been strengthened by consumer opposition, which has been especially strong in Japan, South Korea, and Europe. Even in the U.S. consumer pressure has forced major food companies like General Mills to speak out against Monsanto's GE wheat.

David Pine on the Israeli Peace Process

On May 7th and 8th, Temple Emek Shalom hosted speaker David Pine, West Coast Regional Director of Americans for Peace Now (APN). Founded in 1981, APN defines itself as "the leading American Zionist organization working to help Israel achieve a secure peace with the Arab states and the Palestinian people".

APN's Israeli counterpart is Shalom Achshav (Peace Now), founded in 1978 by 348 reserve officers of the Israeli Defense Forces.

A disarming, gentle-spoken man, Mr. Pine opened with a poignant, yet humorous, tale of an old Jewish man who had been coming to the Wailing Wall in Jerusalem for 50 years to pray for peace between the Israelis and Palestinians. When asked how he felt after so many years without a resolution to the conflict, the old man replied, "It's like beating your head against a wall." Following the mellow chuckle which circulated around the room, Mr. Pine then discussed the roles which the three major parties in the peace process (Israelis, Palestinians, and US) should play.

Mr. Pine believes that Israel has a need for defensible borders but a permanent wall is not a solution. He maintains that the impediment of a permanent wall as well as a proliferation of redundant checkpoints within Palestinian territory hinder efficient commerce and productivity in Arab neighborhoods where poverty can be 2 to 3 times higher than in Jewish townships. Mr. Pine supports Sharon's policy of removing settlements but feels that this is counteracted by Sharon's refusal to communicate with Palestinian leadership.


On the other hand, the Palestinians, he stresses, have an obligation to denounce terrorism as a solution and to shun Yassir Arafat whom, it is felt, appears ambivalent if not supportive of terrorist tactics and organizations.

The recent, though unofficial, Geneva agreement which detailed a plan for a two-state system for the region is a good start, according to Mr. Pine. As to the United States' influence on the peace process, Mr. Pine feels that there is little to differentiate the competing presidential platforms at this time. APN appreciates president Bush's support of a two-state plan for Israel but feels that the US needs to play a greater role to encourage negotiations between the parties. It Might Take a Village To Solve Some Social Problems

Children and the elderly sometimes seem to be locked in a zero-sum conflict for limited funding and services, demanding difficult choices from policy-makers. Making just decisions is challenging: how should we weigh the relative merits, for example, of a program to provide subsidized housing for fixed-income seniors, versus another that provides tutoring and emotional support for foster children?

Most attempts to deal with such problems through public and private service-entities come to be seen as problems of management expertise, efficient logistics, and inevitable tradeoffs.

But occasionally a community turns out to express itself coherently without bureaucratic direction, and realizes imaginative solutions to complex problems. The organizations which emerge are often difficult to classify, being hybrid entities.

Generations of Hope is one such innovation. Located on a deactivated military base in central Illinois, Hope provides housing and professional support to ten families who adopt children from the foster care system. All live as neighbors in Hope Meadows, a planned suburban development utilizing former base housing. Intermingled with the family homes are an additional forty-seven rental units occupied by senior citizens, who provide services to the children and to the project in exchange for reduced rent.

Social alchemy

This strategy of combining three or more generations of kin-like support in a secure

and welcoming neighborhood has paid off: seniors have a safe and affordable place to live, families at last receive adequate support for the often overwhelming task of adopting "special needs" foster children, and the children find an end to (or even avoid) a long series of temporary placements and painful disruptions.

Multiple sources of need are combined at *Hope* in a single crucible, and a peculiar alchemy ensues in which needs become resources, resources become multiplied, and certain stubborn costs seem to drop away altogether.

The *Hope* innovation poses interesting challenges to business-as-usual in the care and service industry, and offers an opportunity for re-imagining public service.

Hope West?

Recently an Ashland-area resident contacted *Hope* about the possibility of replicating the program, and offered to provide land for a *Hope Meadows* neighborhood development near Hilt, California.

Still needed: A few visionary local (Ashland-area) community leaders interested in exploring the feasibility of replicating the *Hope* model: to assess the need, to connect with local agencies, to strategize funding, and potentially to develop a working business plan, with the assistance of *Generations of Hope* in Illinois.

Support Conscientious Objector Camilo Mejia

Staff Sergeant Camilo Mejia of the Florida National Guard spent six months last year dodging roadside bombs, mortars and ambushes in Iraq's Sunni triangle. He concluded that the war was predicated on a lie, that U.S. forces were not welcome "liberators" but unwanted occupiers responsible for the deaths of Iraqis and the destruction of their country. Home on furlough in the United States, he decided not to return.

S/sgt. Mejia is claiming conscientious objector status; the first veteran of the Iraqi war to do so. The army, however, is charging him later this month as a deserter. Says Mejia: "They make it seem that if you don't support what the government is doing then you are unpatriotic, and if you don't support the war, you don't support the troops. I felt that somebody had to come forward and say: I support the troops but I don't support the war."

Mejia's mother, Maritza Castillo, has appealed for support for her son, who is confined to Fort Stewart, GA, and is barred from conducting interviews. On her behalf, the Fellowship of Reconciliation urges that messages of solidarity be sent to Mejia (address below) and protests to the military (also below.) As information emerges about the torture, rape and abuse of Iraqi prisoners at Abu Ghraib, and the killing of hundreds of civilians in Fallujah, it becomes critical to support those troops brave enough to disassociate themselves from this horror.

Castillo, who is active with Military Families Speak Out, says her son's application for conscientious objector status is being denied in the context of an immoral war. "President Bush does not give any explanation about the weapons of mass destruction that have not been found and for which he invaded and bombarded the people of Iraq and sent our young soldiers to die; Instead, he makes a mockery about the reasons he's had for spending the money of the American people in this bellicose adventure. When he is asked about the weapons of mass destruction and the chemical weapons, he responds with vulgar gestures."

S/sgt. Mejia may be the first Iraq veteran to apply as a conscientious objector, but he isn't the first to refuse to return to the war. Even the Pentagon acknowledges that morale is very low. So far, most of the doubters have gone AWOL. The Marine Corps alone registered 1,123 cases of desertion in 2003 and nearly 400 so far this year. Since the start of the war, 29,000 troops have called an advice hot line run by the Central Committee for Conscientious Objectors.

indeed shocking, but in such a climate, it is not surprising.

Who are the victims of this maltreatment? According to a February Red Cross report, the U.S.'s own military intelligence officers estimated that 70-90 percent of "persons deprived of their liberty in Iraq" were innocent of any wrongdoing. Other intelligence officers assert that most of the Abu Ghraib detainees were caught up in general "sweeps," in the hope that they might provide useful information.

The innocence or otherwise of the detainees abused and tortured is, of course, irrelevant. What was done to them is against international law, as well as every religious and moral tenet of decency or compassion. That so many of them had done nothing to deserve incarceration in the first place merely demonstrates how degraded U.S. judgment has become and why our troops should leave Iraq now.

The violence of the last few weeks throws light on an essential truth: The "enemy" holds no monopoly on evil and "our side" no monopoly on good. All humankind has the capacity to perpetrate evil and violence upon its fellows. All violence, whether depicted graphically in photographs and videos, or taking place anonymously, out of the camera's range, is an affront to the God-given humanity of all. Americans now face the humbling task of asking themselves and their government how it could possibly have been in any nation's interests to provoke such violence by invading and occupying a nation that never attacked us.
